3. The Bids shall be deposited in electronic format on the website: <http://jktenders.gov.in> from **26-02-2020** to **11-03-2020** up to **1600 Hrs.** The bids received will be opened **on 12-03-2020 at 1400 Hrs. online.**
  - a) b. The complete bidding process will be online.
  - b) C. Bids of bidders shall be opened on line in the office of **Chief Executive Officer SRINAGAR SMART CITY LTD** on **12-03-2020 at 1400hrs.**
  - c) d. The lowest bidder i.e. L1 shall be intimated to deposit the original copy of required earnest money in the shape of CDR / FDR and Hard copies of all relevant document as mentioned in clause 02 of general instructions to the bidders within 03 days from opening of financial bids.
  - d) e. Cost of tender documents should be submitted by the bidder in the shape of Demand Draft pledged to Chief Executive Officer Srinagar Smart City Limited and uploaded the same.
4. Bid documents can be seen at and downloaded from the website <http://jktenders.gov.in> Bid documents contain qualifying criteria for bidder, specifications, conditions and other details.
5. The site for the work is available.
6. Bids must be accompanied by bid security and cost of Tender Document as specified in column 5 of the table above payable at Srinagar pledged to **Chief Executive Officer SRINAGAR SMART CITY LTD** Bid security will have to be in any one of the forms as specified in the bidding documents and shall have to be valid for Six (6) months after the opening of Bid. The cost of downloaded tender documents in the form of Demand Draft pledged to Chief Executive Officer Srinagar Smart City Ltd..
  - a. Bids will be opened in the office of the **Chief Executive Officer SRINAGAR SMART CITY LTD** on **12-03-2020 at 1400hrs.** If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
7. The bid for the work shall remain valid for acceptance for a period of **180-days** from the date of opening of bids.
8. **Instruction to bidders regarding e-tendering process**
  - a) The interested bidder can download the NIT/bidding document from the website <http://jktenders.gov.in>.
  - b) To participate in bidding process, bidders have to get (DSC) "Digital Signature Certificate" as per Information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid bidders can get abovementioned digital certificate from any approved vendors. The Bidders, who already possess valid (DSC) Digital Signature Certificates, need not to procure new Digital Signature Certificate.
  - c) The bidders have to submit their bids online in electronic format with Digital Signature. The bids cannot be uploaded without Digital Signature No Proposal will be accepted in physical form.
  - d) Bids will be opened online as per time schedule mentioned in Para 3(a).
  - e) Before submission of online bids, bidders must ensure that scanned copy of all the necessary documents have been attached with bid. Details of Document required is available along with downloadable tender document on <http://jktenders.gov.in>
  - f) The department will not be responsible for delay in online submission of bids whatsoever reasons may be.
  - g) All the required information for bid must be filled and submitted online.
  - h) **The tenderer should quote his rate in such a way that the total amount of work amounts with a fraction amount the fractional amount between 0 to 50 Paise will be treated as Nil and above 50 Paise rounded up to next rupee.**
  - i) **In case two or more tenders have quoted equal amounts for executing the work the allotment shall be made to the bidder having highest turnover for last three consecutive years.**
10. Bidders can contact the undersigned for any guidance for getting DSC or any other relevant details in respect of e-tendering process.

11. In case of lowest bid value being below the advertised cost, following additional performance security in the shape of CDR/FDR shall have to be deposit by the successful bidder within a week from the date of intimation.

The bidders are instructed to read carefully the BOQ. Any item showing blank cells in the column of "Rates" should be treated as RTQ (Rate to be quoted). The bidders should accordingly bid rates for all items

12. **Special Condition**

- a) **Inspection:** The stage inspection/survey of the finished product will be conducted (before shipping) at OEM facility/assembly line by a joint designated team of three persons /experts from Fire & Emergency Service Dept Srinagar & SSCL. All the expenses including airfare (to and fro) including accommodation and food shall be borne by the supplier for the inspection period of minimum 3 days (working) from the date of arrival of these experts.
- b) **Validity:** the rates approved are in force for one year from the date of issuance of the first supply order.
- c) **Warranty:** The equipment shall carry a warranty of One Year from the date of acceptance by the department (Commissioning).
- d) **Penalty:** The department will be at liberty to impose penalty as it deems proper which also includes forfeiting of security deposit amount, if the firm back out or fails to supply the ordered quantity within the stipulated delivery period or supplies substandard equipment not as per specifications. However, the period of delivery may be extended at the discretion of Joint Director, Fire & Emergency Services, Srinagar/CEO SSCL provided the delay is caused due to force majeure reasons beyond the control of supplier firm but not attributable to business transactions and also delay in communicated in writing justifying the cause delay. Consideration of the force majeure shall, however, remain.
- e) **Insurance:** Insurance cost of the Equipment to be borne by the supplier himself to the delivery site (Dal Lake Srinagar).
- f) **Terms and Conditions of Payment:**
- 25% of the allotted cost will be released after the successful stage inspection as and when certified by the inspection team.
  - EMD will be released after the successful stage inspection certified by the inspection team.
  - 65% of the allotted cost will be released after successful testing & commissioning as and when certified by the inspection/testing team at Dal Lake.
  - 10% Retention money will be released after the completion of the warranty period.

**Laws governing the Contract:-** The contract shall be governed by laws of the land.

**Court's Jurisdiction:** - In case of any disputes/difference between contractor and Departments, the Hon'ble Court of J&K state shall have the jurisdiction.

**Special Conditions:**

- The intending bidder must furnish the latest GST and IT return along with the Bid.
- The intending bidder should have the minimum turnover of 150 lacs for the last three consecutive years, that is, for the year 2016-17, 2017-18 and 2018-19
- The deliveries should be completed within stipulated time mentioned above from the date of LOI/Allotment order. In case of any delay in completion of works the penalty of 2000 per day shall be imposed upon the supplier to whom the work is allotted.
- The bidder must upload all relevant documents like CDR/FDR /Demand draft /PAN /Recent GST return/Recent ITR /Bank statement/Balance sheet etc.
