- 7. Interested and eligible bidders may submit their complete proposal as prescribed in the Bid Document along with the receipt of requisite Bid Document Cost.
- 8. The eligible bidders registered as Micro and Small Enterprises shall be provided bid document free of cost and shall be exempted from depositing Bid Security subject to furnishing of relevant valid certificate/documents for claiming such exemption. However, in lieu of Bid Security, the MSE bidder is required to submit the Bid Security Declaration on a duly notarized non-judicial stamp paper of Rs. 100/- in the format as provided in the Bid Document.

The bidder is required to quote the Monthly License Fee (MLF) per parking slot in an amount not less than the "Minimum Monthly Reserved Bid Amount per Parking Slot" and the selection will be done on Highest Quoted Monthly License Fee per Parking Slot which the bidder intends to pay to the Authority out of the total earned Gross revenue as per the procedure described in the RFP.
- 10. Right to revise or amend this notice and / or the Bid Document, fully or partially, prior to the last date notified for submission of offers or on any subsequent date is reserved by the Employer.
- 11. The Employer will not be responsible for any delay in submission of bid due to any reason.
- 12. The Employer reserves the right to accept or reject any or all proposals, cancel the bidding process, at any time prior to the award of contract, without assigning any reason therefor and thereby assumes no responsibility of incurring any liability to the affected applicants.
