- 4 The Earnest Money Deposit (Bid Security) may be paid through CDR/FDR/DD in favour of Srinagar Smart City Limited with Bank Account details as stated above or may be submitted through a Bank Guarantee having a validity of 60 days beyond Bid Validity Period of 120 days. The Bank Guarantee shall be pledged to Chief Executive Officer, Srinagar Smart City Limited, Srinagar and shall be submitted in the format provided in the Bid Document (see Form Tech 13).
- 5 If any date specified herein is a holiday, then the next working day will be considered for the activity and the time will remain the same.
- 6 The bids shall remain valid for a period of 120 days from the due date of submission of bids. To this effect, the bidder has to submit, along with his bid, a duly filled and signed "Bid Securing Declaration Form" provided in the RFP document.
- 4. The bidder is required to quote the year-wise percentage of gross revenue to be shared with the Authority and the selection will be done on Highest Average of quoted Year-wise Percentage of Gross Revenue Share as per the procedure described in the RFP.
- 5. The eligible bidders registered as Micro and Small Enterprises shall be provided bid document free of cost and shall be exempted from depositing Bid Security subject to furnishing of relevant valid certificate/documents for claiming such exemption. However, in lieu of Bid Security, the MSE bidder is required to submit the Bid Security Declaration on a duly notarized non-judicial stamp paper of Rs. 100/- in the format as provided in the BidDocument.
- 6. The Contract period shall be as follows:
