The eligible bidders registered as Micro and Small Enterprises shall be provided bid document free of cost and shall be exempted from depositing Bid Security subject to furnishing of relevant valid certificate/documents for claiming such exemption. However, in lieu of Bid Security, the MSE bidder is required to submit the Bid Security Declaration on a duly notarized non-judicial stamp paper of Rs. 100/- in the format as provided in the Bid Document.
10. The bidder is required to quote in the prescribed format provided on the e-procurement portal and the selection will be done on least cost basis.
