The Bank Guarantee shall be pledged to Chief Executive Officer, Srinagar Smart City Limited, Srinagar and shall be submitted in the format provided in the Bid Document.

The eligible bidders registered as Micro and Small Enterprises shall be provided bid document free of cost and shall be exempted from depositing Bid Security subject to furnishing of relevant valid certificate/documents for claiming such exemption. However, in lieu of Bid Security, the MSE bidder is required to submit the Bid Security Declaration on a duly notarized non-judicial stamp paper of Rs. 100/- in the format as provided in the Bid Document.
- 10. The bidder is required to quote the Annual License Fee which the bidder intends to share with the Authority and the selection will be done on the basis of Highest Annual Revenue Share Amount quoted by any bidder and as per the procedure described in the RFP.
