The Earnest Money Deposit (Bid Security) may be paid through CDR/FDR/DD in favour of Chief Executive Officer, Srinagar Smart City Limited, with Bank Account details as stated above or may be submitted through a Bank Guarantee, having a validity of 60 days beyond Bid Validity Period of 90 days. The Bank Guarantee shall be pledged to Chief Executive Officer, Srinagar Smart City Limited, Srinagar and shall be submitted in the format provided in the Bid Document.

The eligible bidders registered as Micro and Small Enterprises shall be provided bid document free of cost and shall be exempted from depositing Bid Security subject to furnishing of relevant valid certificate/documents for claiming such exemption. However, in lieu of Bid Security, the MSE bidder is required to submit the Bid Security Declaration on a duly notarized non-judicial stamp paper of Rs. 100/- in the format as provided in the Bid Document.
- 9. The bidder is required to quote in the prescribed format provided on the e-procurement portal and theselection will be done on least cost basis.
- 10. Right to revise or amend this notice and / or the Bid Document, fully or partially, prior to the last datenotified for submission of offers or on any subsequent date is reserved by the Employer.
- 11. The Employer will not be responsible for any delay in submission of bid due to any reason.
- 12. The Employer reserves the right to accept or reject any or all proposals, cancel the bidding process, atany time prior to the award of contract, without assigning any reason therefor and thereby assumes no responsibility of incurring any liability to the affected applicants.
